Monthly Fee \$80.00 AUD

Your monthly fee will cover basic education costs for your child, including school uniforms, shoes and socks, transport to school, books and homework resources plus extracurricular activities such as Scouts excursions, Scouts uniforms and equipment, after school sports equipment including soccer boots and socks or netball uniforms. Also included are 2 meals a day at school and school excursions.

CHILD DETAILS

You will be provided with a welcome pack, which includes a photograph and small biography about your sponsored child. Details on how you can communicate with your sponsored child will also be provided.

Your monthly donation will be used to:

- Provide education and educational supplies to children living in substandard living conditions.
- Service children's basic health needs, such as food, clean water and access to medical attention.
- Provide and assist with repair and/or construction of accommodation for children, to provide suitable living conditions with protection from the elements.
- Provide social welfare services to ensure the wellbeing of children.
- A contribution of \$30 p/m is sufficient to cover basic education costs for one child, including school uniforms, shoes and socks, transport to school, books and homework resources.
- A contribution of \$60 p/m covers basic education costs for one child, including school uniforms, shoes and socks, transport to school, books and homework resources plus extracurricular activities such as Scouts excursions, Scouts uniforms and equipment, after school sports equipment including soccer boots and socks or netball uniforms.
- A contribution of \$80 p/m provides basic education costs for a child, including school uniforms, shoes and socks, transport to school, books and homework resources plus extracurricular activities such as Scouts excursions, Scouts uniforms and equipment, after school sports equipment including soccer boots and socks or netball uniforms as well as 2 meals a day at school and school excursions

PAYMENT DETAILS

Payment is to be made by direct debit from either a bank account or credit card. Please sign and complete the attached direct debit form and return to us along with this agreement.

All direct debit payments will be managed by Ezidebit® ACN 096 902 813. Payment is to be made by direct debit by an accepted method of payment of Ezidebit®.

By signing this agreement you:

1. Agree to complete and sign the attached Ezidebit® Direct Debit Request new Customer Form and return it to us along with this signed agreement;

2. Consent to your personal information being shared with Ezidebit® for the purposes of establishing and maintaining your monthly sponsorship;
3. Agree to abide by all Ezidebit® terms and conditions including those contained with the Ezidebit® Direct Debit Request New Customer Form;
4. Confirm your nominated direct debit account will accept a direct debit with Ezidebit®; and
5. Agree to advise us if the nominated bank account or credit card account with Ezidebit® is transferred or closed.

Alternatively, if you wish to make payments directly into our bank account please contact us at admin@thefoundation.org.au as any such alternative arrangements must be agreed to by us.

TERMS & CONDITIONS

1. The sponsor agrees to make monthly donations to Q Foundation Ltd in accordance with the Ezidebit® direct debit authority, and in accordance with the Sponsorship Agreement. These donations are due on the agreed date each month. (eg: if your first payment comes out on the 9th, subsequent payments will be on the 9th of each month)
2. Monthly payments will continue until termination of the Agreement. The sponsor agrees to contact Q Foundation Ltd in writing to advise that they wish to terminate this agreement. Please contact us via email admin@thefoundation.org.au or by writing to Q Foundation Ltd PO Box 816 Helensvale Qld 4212. Allow up to 28 days for this request to be actioned.
3. The sponsor must advise Q Foundation Ltd in writing, with a minimum of 28 days notice, if they wish to cancel or make adjustments to their direct debit agreement to allow time for processing. Please contact us via email admin@thefoundation.org.au or by writing to The Q Foundation Ltd PO Box 816 Helensvale Qld 4212. Allow up to 28 days for this request to be actioned.
4. Sponsorship payments and donations are non-refundable once funds are received by Q Foundation Ltd. The sponsor has no claim as to the appropriate application of the funds provided the application is in accordance with Q Foundation Ltd's charitable purpose as stated in its constitution.
5. The sponsor shall be liable for direct debit fees and charges payable to Ezidebit®, including but not limited to administration, transaction, credit card fees and dishonour charges where applicable.
6. If a direct debit payment is unsuccessful, Ezidebit® then will process payment of any applicable dishonour fees and Q Foundation Ltd will attempt to contact you to discuss the matter. If payment is unsuccessful after the second attempt your account will be placed on hold and we will contact you to discuss the matter. Ensure your contact details with the Q Foundation Ltd are kept up to date.
7. If sponsorship payments are not received for two consecutive months, Q Foundation Ltd reserves the right to cancel your sponsorship without notice. The sponsor shall remain liable for any outstanding fees and charges owed to Ezidebit® and associated collection costs.

8. Q Foundation Ltd has the right to terminate the Agreement by written notice at its absolute discretion without the requirement to provide any reason and any surplus funds upon termination of the sponsorship agreement will be transferred to a community account which is used to support the villages and surrounding areas of children sponsored by Q Foundation Ltd or another sponsored child.
9. Q Foundation Ltd will identify and support sponsored children in accordance with its constitution.
10. Sponsored children will receive financial support until such time that they cease education, are financially independent, or are considered no longer eligible for any other reason at the discretion of the directors of Q Foundation Ltd. Sponsorship funds will be allocated to the sponsored child, and any surplus funds upon termination of the sponsorship agreement will be transferred to a community account which is used to support the villages and surrounding areas of children sponsored by Q Foundation Ltd or another sponsored child.
11. Once off donations, or donations for a specific purpose (i.e. birthday gifts) can be made in addition to your ongoing monthly agreement. Please contact us via email admin@thefoundation.org.au or visit our website www.thefoundation.org.au to discuss this matter.
12. This sponsorship agreement may be used to support another child at the discretion of Q Foundation Ltd. The sponsor will receive written notice within 28 days of any changes to their sponsored child. (refer Terms and Conditions 8).
13. Tax receipts will be issued for all donations, along with an annual statement which will be sent out in July of each year to your nominated e-mail address. If you require a tax invoice prior to making your donation, please contact admin@thefoundation.org.au .
14. Q Foundation Ltd reserves the right to change any term of the agreement. Q Foundation Ltd will provide you 14 days written notice in the event it seeks to change any term of the agreement and if you do not object to the changes within the 14 days, you will be bound by such changes.
15. Nothing contained or implied in this agreement creates or purports to create any partnership, employment, agency, trust or other like relationship between Q Foundation Ltd and the sponsor.
16. Nothing contained or implied in this agreement creates or purports to create any paternal or guardianship rights between the sponsor and any sponsored child.
17. The sponsor agrees to indemnify and keep indemnified Q Foundation Ltd against any liability, actions, claims, demands, damages, costs and expenses incurred or suffered by Q Foundation Ltd or its related bodies corporate in connection with or arising in any way out of the sponsorship or a breach by the sponsor of the Sponsorship Agreement.
18. To the full extent permitted by law, Q Foundation Ltd excludes all representations, warranties or terms (whether express or implied) other than those expressly set out in this agreement.
19. Q Foundation Ltd is not responsible for any loss or damage suffered by the sponsor as a result of any fraudulent acts of any individual or body corporate in purporting to act on behalf of Q Foundation Ltd.

20. The sponsor must not assign this agreement without the prior written consent of Q Foundation Ltd, which consent Q Foundation Ltd may withhold in its absolute discretion. Q Foundation Ltd may at its discretion assign all or any of its rights under this agreement.

PRIVACY POLICY

1. Q Foundation Ltd will collect and use your personal information for internal record keeping and communication purposes and share your information with Ezidebit for billing purposes.
2. Q Foundation Ltd will not share or publish your personal information without express written consent from you.
3. Q Foundation Ltd will store your personal details in a safe and secure manner.
4. You must advise us of any changes to your personal details as soon as possible.
5. Personal information will only be shared between sponsors and beneficiaries if and when it is deemed appropriate. Beneficiaries will only be advised of their sponsors name and country of residence unless you request, in writing, for us to disclose further information. We reserve the right to withhold certain information in regards to beneficiaries/sponsored children if it is in the best interests of the child and/or Q Foundation Ltd to do so. If a sponsor wishes to communicate with their sponsored child, the sponsor must firstly contact Q foundation Ltd via email admin@thefoundation.org.au or by writing to Q Foundation Ltd PO Box 816 Helensvale Qld 4212 for approval and further instruction as there will be restrictions on methods of communication and recognition of cultural differences.
6. Q Foundation Ltd is permitted to use any successful child sponsorship story as part of the Foundation's marketing or advertising campaign, on the basis that no personal information of the sponsor is made public.
